ORDER (Oral)

Per A.K. Patnaik, Judicial Member:

Heard Mr. A. Chakraborty, Ld. Counsel appearing for the applicants and Mr. B.P. Manna, Ld. Counsel appearing for the official respondents.

2. The applicants have filed a memo seeking withdrawal of the instant O.A. along with liberty to make a comprehensive representation addressed to respondent No. 5. I find that on an earlier occasion i.e. on 23.6.2016 a Division Bench of this Tribunal has allowed the applicants to implead the names of their juniors in the instant O.A. and after that it was observed that some amendments were carried out but in black ink, which is also not permissible.

3. However today by filing a memo when the applicants sought liberty of this Tribunal to withdraw this O.A. to make a comprehensive representation, I do not think it will be prejudicial to either of the parties if the O.A. is allowed to be withdrawn and the applicants are granted liberty to prefer a comprehensive representation annexing all the required documents addressed to respondent No. 5 and, if any such representation is preferred within a period of two weeks from today, then the respondent No. 5 may consider the same as per rules and regulation in force and pass a reasoned and speaking order within a period of three months from the date of receipt of a copy of this order.

4. I make it clear that I have not gone into the merits of the matter and all points are kept open for the respondent No. 5 to consider the same as
