ORDER

Mr. A.K. Patnaik, Judicial Member

The 229 Applicants have filed this Original Application U/s. 19 of the Administrative Tribunals Act, 1985 seeking the following reliefs:

"(a) An order directing the respondents to set aside the order dated 08.7.2014 and 1.9.2015 (Annexure-A/11 and Annexure A/12) and further directing the respondents No.3 to collect the all documents individually immediately from the applicants and verify the same, if the applicants are found suitable, then regularize the applicants in the suitable post as per their working position;

(b) An order directing the respondents to take similar decision which was taken by the Malda Division and also treat the applicants according to Annexure A/14 and A/16 collectively basis;

(c) Leave may be granted to the applicants to file this application jointly under Rule 4 (5) (a) of the CAT Procedure Rules, 1987;

(d) Pass any other or further order or orders as to this Hon'ble Tribunal may deem fit and proper."

The applicants have also filed an M.A. No.350/101/2017 seeking permission to file this single O.A. jointly under Section 4(5)(a) of C.A.T. (Procedure) Rules, 1987.



2. Before proceeding further in the matter, the orders impugned in this OA are quoted herein below:

(i) The order dated 08.07.2014 (Annexure-A/11) issued by the Divisional Railway Manager, Howrah:-

"In obedience to the judgment of Hon'ble CAT/ Calcutta in O.A.No.350/00143/2014, 350/00144/2014, 350/00145/2014, 350/00146/2014, 350/00167/2014 dated 26.2.14, the undersigned being concerned with the petitioner of Howrah Division has carefully gone through the claim of the petitioner pertaining to Howrah division and observed as under:

The petitioner alleged that they have worked as contract labourer under different contractors for performing the work in Railway administration for the job of Safaiwala for sweeping, cleaning of yard, platform, stores office and garden including drains/latrines, sprinkling of saw, a scraping and collection of garbage/rubbish mud etc. in different stations, sheds, yards and office/units etc. With the alleged aforementioned claim they demanded their absorption in railway service.

As ordered by Hon'ble CAT/Calcutta, the petitioner through their Ld. Advocate submitted documents such as photocopy of I. Card issued by the Contractors under whom they worked, a list of documents with names, sex, photo etc. The said documents were examined and it is seen that they stated to have worked under different contractors i.e. Social Construction Company, Lotus Security Services, Govt. Contractor (Railway & Civil) etc. After perusal of railway documents pertaining to Howrah Division of Eastern Railway, it is evident that railway administration of Howrah Division of Eastern Railway never deployed any contract with the aforementioned contractors.

Pertinently it is mentioned that Railway administration of Howrah Division, Eastern Railway for carrying out cleaning process in different units only enters into a job contract with a qualified Labour Contractor and railway administration never invites any Labour Contractors for



conducting cleaning process. The explicit terms and conditions nowhere reflect any promise or undertaking that mentioned absorption of the labourers in the Railways who are so engaged by the nominated Labour Contractors; thus no agreement is executed between the Labourers and Railway Administration.

In contractual agreement, when a Contractor undertakes to produce a given result by engaging Contractors Labour, the relationship of Master and Servant exists between the Contractor and Contract Labour and not between the Principal Employer and Contract Labour. The responsibility of the principal employers under the Contract Labour (Regulation & Abolition) Act, 1970 arise only in the event of failure of the contractor to fulfil his statutory obligations. Even when the appropriate Government prohibits the employment under the said Act, there is no provision for automatic absorption of contract labour into Railway under the said Act.

In the Railway Administration, intake of incumbent to a permanent/temporary post is generally done through statutory method of recruitment of Railway Recruitment Agency. There is no system of automatic absorption of Contract Labours.

Under the above premises, Contract Labour is not eligible under any agreement between the Contractor and Railway Administration for consideration of their absorption/appointment in Howrah Division of Eastern Railway as they were never engaged in the said work by the Railway administration of Howrah Division of Eastern Railway. So their claim is not tenable.

As such, the undersigned has no option but to reject the claim of petitioner.

Thus, the cases stand disposed of."

- (ii) The order dated 1.9.2015 issued by the Divisional Railway Manager, Eastern Railway, Howrah (Annexure A/12) :-

"In compliance to the judgment dtd.16.6.15 of Hon'ble CAT/Calcutta in MA.No.350/00210/2015 arising out of OA



No.350/00625/2015, I, being the respondent No.3 have gone through the joint representation dtd.19.7.15 of the applicants along with other relevant records & rules and observed as under:-

In the OA as well as joint representation, the Petitioners alleged that they have worked as Contract Labourer under different contractors for performing the different works related to different type of cleaning works etc. In the Eastern Railway, their basic claim is that according to Indian Railway Establishment Manual, Vol.II, para 2001, they should be given the status of Casual Labour and their Service should be governed by the Railway Rules.

Chapter XX para 2001 of IREM Vol.II speaks as under:-

"Casual labour refers to labour whose employment is intermittent, Sporadic or extends over short period or continued from one work to another. Labour of this kind is normally recruited from the nearest available source. They are not ordinarily liable to transfer. The conditions applicable to permanent and temporary staff do not apply to casual labour.

Casual labour on Railway should ordinarily be employed only in the following types of cases.

- (a) Casual Labour(Open Line) – Casual labour are primarily engaged to supplement the regular staff in work of seasonal or sporadic nature, which arises in the day to day working of the Railway system. This includes labour required for unloading and loading of materials, special repair and maintenance of tracks and other structures, supplying drinking water to passengers during summer months, (recoupment of man-days lost on account of absenteeism) patrolling of tracks, etc. casual labour so engaged in the operation and maintenance of railway system is referred to as open line casual labour, as distinct from project Casual Labour, described in para (b) infra.
- (b) Casual Labour (Project) – Casual Labour are also engaged on Railways for execution of Railway projects, such as new lines, doubling, conversion, construction of building, track Renewals, Route Relay interlocking Railway Electrification, Setting up of new units etc. Casual Labour so engaged are referred to as Project Casual Labour."

In this regard it is clarified that Casual Labours were engaged by the Railway Administration for the job mentioned above as per casual requirements. The petitioners do not come under the purview of the said definition.

The applicants earlier approached to the Hon'ble Tribunal vide OA No. 143/2014 and in compliance to the judgment dtd. 26.2.2014, a speaking order was issued vide this office letter No. E/Court Cell/C. Labour. dtd. 8.7.14. The applicants again approached to Hon'ble Tribunal vide OA No. 350/00625/2015 for the same cause of action and no new fact has been brought. In this regard it is reiterated that Railway Administration of Howrah Division, Eastern Railway enters into a job contract with a qualified Contractor for carrying out cleaning process in different units only and Railway Administration never invites any Labour Contractors for conducting cleaning. The explicit terms and conditions nowhere reflect any promise or undertaking that mentions absorption of the Labourers in the Railways who are so engaged by the nominated Contractors; thus no agreement is executed between the Labourers and Railway Administration.

In Contractual agreement, when a Contractor undertakes to produce a given result by engaging Contract Labour, the relationship of Principal and Agent exists between the Contractor and Contract Labour and not between the Principal Employer and Contract Labour. The responsibility of the Principal employers under the Contract Labour (Regulation & Abolition) Act, 1970 arises only in the event of failure of the Contractor to fulfil his statutory obligations. Even when the appropriate Government prohibits the employment under the said Act, there is no provision for automatic absorption of Contract Labour into Railway under the said Act.

In the Railway Administration, intake of incumbent to a permanent/temporary post is generally done through statutory method of recruitment of Railway Recruitment Agency. There is no system of automatic absorption of Contract Labour.

Will

In view of the above, Contract Labour is not eligible under any agreement between the Contractor and Railway Administration for consideration of their absorption/appointment in Howrah Division of Eastern Railway as they were never engaged in the said work by the Railway Administration of Howrah Division of Eastern Railway. As such, the claim of the petitioners is not tenable, hence regretted.

Thus, the joint representation dtd. 19.7.15 submitted by the applicants stands disposed of."

3. The case of the applicants, in nut shell, is that after being engaged through contractors all of them are performing the duties of Supervisors, Sweeper, Cleaner, Safaiwala etc of the Railway and had completed 340 days' work in the railway. In terms of the Indian Railway Establishment Manual Vol.II, Para 2001 those who have completed more than 120 days of work continuously without any break, shall be given the status of casual labours and their service conditions shall have to be governed by the relevant rules of the Railways. The work of the railway being performed by them are perennial in nature. It has been stated that in other divisions persons engaged through contractor, like the present applicants, were regularized and as such, the applicants have a right to be regularized. In this regard, the applicants have also placed reliance on the decisions of the Hon'ble Apex Court in the cases of **Union of India & Ors Vs Railway Yatri Nivas, N.D. Staton U & Others Special Leave to Appeal (Civil) No. 587/2000** and **Union of India Vs Lalua Belur Coop Lab Contr & ST & Another dated 14.09.2012 in Special Leave to Appeal (Civil) No. 14737-14738 of 2012.**

4. We have heard Mr. T.K. Biswas, the learned counsel appearing for the applicants and Mr. L.K. Chatterjee and Mr. A.K. Guha, learned counsel

appearing for the Railway-Respondents and perused the pleadings and materials placed in support thereof including the decisions relied on by them.

5. Undisputedly, the engagements of the applicants were through contractors and not directly by the Railway. It is also not the case of the applicants that the contractors engaged them after following the Rules existing in the Railway for appointment to Gr. C or D posts. It is also not the case of the applicants that their engagement or appointment were against sanctioned posts. The mandate enshrined in Articles 16 of the Constitution of India provides that all citizens of India are entitled to get equal opportunity for the purpose of obtaining employment in State Service. In order to fulfil such a condition, it is necessary to consider the cases of all citizens who are eligible to be appointed. For that purpose, it is not only necessary to call for the names from the Employment Exchange, but in some cases also required due advertisement of posts in Newspapers by notifying the vacancies and the requisite qualifications so that all eligible candidates may apply for their appointment in the said posts. It cannot, thus, be stated that the petitioners had been appointed upon compliance of the recruitment process as envisaged under the Rules or upon compliance with the principles enshrined under Article 16 of the Constitution of India.

6. The stand of the applicants is that as they had completed more than 120 days of work continuously without any break, in terms of the Indian Railway Establishment Manual Vol. II part-I, they have acquired a status of casual labourers and as is misnomer because as admitted by the petitioners they were not recruited directly by the railway after following the procedure prescribed under the rules that too against sanctioned posts and, as such, they do not acquire any indefeasible right to claim regularization by stating

violation of any rules. In the case of **Madhyamik Shiksha Parishad Vs. Anil Kumar Mishra and others**, reported in AIR 1994 SC 1638, the Hon'ble Apex Court have held that the daily wagers are deployed on temporary assignment only and not on sanctioned post and completion of 240 days work by daily wager cannot attribute status of a casual workman under Industrial Disputes Act and as such does not create a right of regularization. The case of the applicant is worst when they were not even appointed on daily wage basis through the Railway. The Applicants are covered and governed by the conditions stipulated in their order of engagement given by the contractor. They cannot claim better right merely because they have continued to discharge the duties of the Railway. It is also not the case of the applicants that for the work they have directly been paid by the Railway.

7. In view of the above, neither the applicants have got any right to claim regularization nor even can they claim their continuance in railway on such basis merely on the ground that they have been working in the railway for long because nobody engaged against the law can be regularized even if he has put in years of service.

The applicants have not produced any rule to justify that even if they have been working through contractor by virtue of the said rules, they have got a right to be regularized but the Respondents did not do so. We have gone through the two decisions relied on by the applicants. In the case of **Rail Yatri Niwas (supra)** the persons engaged in the Rail Yatri Niwas approached the Hon'ble High Court and as per the order of the Hon'ble High Court the Labour Commission enquired into the matter and has come to the conclusion that the proceedings will ensure to the benefit of the workmen and accordingly, the Hon'ble Apex Court directed for consideration of the cases of

all

those applicants. The facts and issues involved in that case are different to the present case and as such the said decision is not applicable to the present case. Similar is the situation in so far as the decision of the Hon'ble Apex Court in the case of **Lilua Belur Coop Lab Cont(supra)** wherein as agreed to by the parties, the Hon'ble Apex Court directed to consider the case of those persons in accordance with the direction of the Hon'ble High which is not the case in hands. Thus, the said case has no help to the applicants in the present case.


8. Lastly, as regards the submission that the action of the Respondents is discriminatory in as much as similarly situated persons have been appointed/absorbed in other Division of the Railway and the applicants are entitled to be regularised is concerned, we are of the considered view that this submission is bound to be rejected as it is well settled that direction for removal of the discrimination can only be issued only when there exists a legal right of the applicants and corresponding legal obligation in the State. Only because of illegality has been committed, the same cannot be directed to be perpetuated. It is trite law that there cannot be equality in illegality. [Ref.: **Sushanta Tagore & Ors. Vs. Union of India & Ors.**, (2005) 3 SCC 16 and **State of Orissa & Ors. Vs. Prasana Kumar Sahoo**, (2007) 15 SCC 129]. In the present case, as discussed above, the applicants having no legal right to claim regularization, this submission of the applicants is rejected.

9. We are reminded by the decision of the Hon'ble Apex Court in the case of **Secy., State of Karnataka v. Umadevi(3)**, (2006) 4 SCC 1. The observation made in paragraph 43 of the said decision is very much relevant for deciding this case and, thus, the same is quoted herein below:

"43 . Thus, it is clear that adherence to the rule of equality in public employment is a basic feature of our Constitution and since the rule of law is the core of our Constitution, a court would certainly be disabled from passing an order upholding a violation

of Article 14 or in ordering the overlooking of the need to comply with the requirements of Article 14 read with Article 16 of the Constitution. **Therefore, consistent with the scheme for public employment, this Court while laying down the law, has necessarily to hold that unless the appointment is in terms of the relevant rules and after a proper competition among qualified persons, the same would not confer any right on the appointee.** when statutory rules are framed under Article 309 of the Constitution which are exhaustive, the only fair means to adopt is to make appointments based on the rules so framed".

10. In view of the facts and law discussed above, we find no merit in this OA. This OA is accordingly dismissed. Consequently the M.A.No.101/¹/_{also} stands dismissed. No costs.
