2. During mentioning hour the Ld. Counsel for the applicants submitted that though the pleadings in this case is complete and the matter is ripe for hearing and it has come up for hearing today but the applicants wants to make another representation to the authorities ventilating their grievance and liberty may be granted for the same.
