**ORDER (Oral)**

**A.K. Patnaik, Judicial Member:**

Heard Mr. A. Chakraborty, Ld. Counsel for the applicant and Ms. M. Bhattacharyya, Ld. Counsel for the official respondents.

2. This OA has been filed by Tarun Das Gupta and 35 ors. challenging inaction on the part of the respondent authorities in not regularizing their services although they got temporary status in the year 1981 after completion of one year's service. This O.A. has been filed praying for the following reliefs:

- "(a) An order do issue directing the respondents to pass an order to the effect that the applicants will be entitled to count full service from the date of attainment of temporary status till the date of regularization and 50% casual service for the purpose of grant of pension and pensionary benefits.
- b) Costs and incidentals
- c) Such further order/orders and/or direction/directions as your Lordships deem fit and proper.
- d) Leave may be granted to add the other applicants in the Original Application jointly under Rule 4 (5) (a) of the CAT Procedure/Rules, 1987.

3. The facts in a nut shell as per Mr. Chakraborty, Ld. Counsel for the applicant are that the applicants are at present working in the Metro Railways. They got temporary status in the year 1981. Although they received temporary status but till date they have not been regularized. The applicants preferred a representation for absorption on 21.11.2016, which is still pending consideration.

4. Mr. Chakraborty, Ld. Counsel for the applicants submitted that the grievance of the applicant would be more or less addressed if a specific

order is passed by directing the concerned authority i.e. respondent No. 2 to dispose of the representation dated 21.11.2016 within a specific time frame.

5. Therefore, I dispose of this O.A. by directing the respondent Nos. 2 that, if any, such representation as claimed by the applicant has been preferred on 21.11.2016 and the same is still pending consideration, then the same may be considered and disposed of within a period of four weeks from the date of receipt of this order.

6. Though I have not entered into the merits of the case still then I hope and trust that after such consideration if the applicant's grievance is found to be genuine then expeditious steps may be taken by the concerned respondent No. 2 from the date of such consideration to extend those benefits to the applicant. However, if in the meantime the said representation stated to have been preferred on 21.11.2016 has already been disposed of then the result thereof be communicated to the applicant within a period of 2 weeks from the date of receipt of a copy of this order.

7. With the aforesaid observation and direction, the O.A. is disposed of.

8. As prayed for by Mr. Chakraborty, Ld. Counsel a copy of this order along with paper book be transmitted to the respondent No. 2 by speed post for which Mr. Chakraborty undertakes to deposit necessary cost in the Registry by the next week.
