Heard. The matter is in a very short compass. Apparently vide para (a), 2015 vacancies, it is shown as follows:

2. Since we have found that there are 8 vacancies, then there is no need for the respondents to say that 2 vacancy apportioned for seniority-cum-fitness were earmarked for UR-1 and ST-1. When SC vacancy exists, it has to be apportioned only for that. It cannot be earmarked for somebody else on any principle. Obviously, there cannot be reservation within the reservation. Therefore, this contention of the respondents is rejected.

3. OA allowed. Applicant is directed to be considered immediately with reference to the earliest point on which he could have been promoted. No costs.
