ORDER (ORAL)**HON'BLE DR.K.B.SURESH ...MEMBER(J)**

Heard. The applicant was directly selected as Postal Assistant in 1982. In 2005 he was given promotion as LSG, which he had declined. Therefore, under the rules, for one year, he will not be considered for promotion again. But then, that does not mean that his right for other career progression will be barred and that remain the substance of this case. Thereafter, he was granted TBOP in 2007 and BCR in 2012, But then that leaves behind one more career enhancement opportunity for the applicant and therefore he is eligible for 3rd MACP on the completion of his 30 years of service. This is declared.

2. OA allowed. The benefits to be made available within 2 months next. No costs.
