Heard. The matter related to compassionate appointment which was rejected on twin grounds of the applicant being 34 years old at the time when he applied for the post and being not qualified. Learned Counsel for the applicant submits that if some time is given within that time he can acquire the qualification. But then after having gone through it, there appears to be practical difficulty as the time required for and time which can be granted are not harmonious. Therefore, we do not think that this is a fit case for interference. The OA deemed to be without merit. Dismissed. No costs.
