Heard. The matter is in a very small compass. Applicant was a Postal Assistant who was appointed on 28.11.2004. He appeared for an examination for Post Master Grade-I on 12.06.2011. The department appointed him on an ad-hoc basis and, protesting against this, applicant declined the promotion. Therefore, under the rules, what could be done is only that for one year he will not have any such promotion. That will not affect his chances for MACP. If he is eligible for MACP, then it must definitely be given to him. The matter is remitted back to the respondents to do the

needful within two months next.

2. The OA is disposed off as above. No order as to costs.
