DR. K.B. SURESH, MEMBER (J):

Heard. The applicant admittedly had been working for the respondents from 2002 to 2016 as a casual labourer. Now under the rules if applicant had

completed 240 days of service in any of the preceding 14 years he is eligible for temporary status and the consequences. We will now remit the matter back to the respondents to look into the casual labour register and the acquittance roll to find out if in any of the preceding years applicant had worked for 240 days or not. If it is so, they will grant him temporary status and consequences within one month next. In this examination, let applicant also have a role to play. Let him also look into the records.

2. The OA is allowed to this extent. No order as to costs.
