The grievance of the applicant is that he is being denied compassionate allowance on the ground that the order by which he is terminated does not mention whether such allowance is to be paid.

We feel, at this stage, that the OA can be disposed of at the admission stage itself by directing respondent No.4 to take a decision on Annexure A8 representation regarding disbursement of compassionate allowance and other terminal benefits, as expeditiously as possible and in any case, within 30 days from receipt of this order. We do so. While the matter is considered by the respondents, due consideration shall be given to the grounds raised in the OA. The OA stands disposed of.
