This application having been heard on 3rd June 2019, the Tribunal on the same day delivered the following :

ORDER (O R A L)

Per : Mr.E.K.BHARAT BHUSHAN, ADMINISTRATIVE MEMBER

The grievance of the applicant, who had voluntarily retired from service with effect from 15.1.1985, is that the respondents have failed to fix his pension in line with those employees who retired from 1.1.1996 which were in accordance with the O.M referred to in Annexure A-2. The applicant submitted that several representations have been made to Respondent No.5 who has been unable to procure his service book from Respondent No.4.

2. Hence, we dispose of this O.A at the admission stage itself by directing the applicant to file a fresh representation highlighting his grievances within a period of one week from the date of receipt of a copy of this order. On receipt of such representation Respondent No.5 shall duly consider the said representation made by the applicant after obtaining the service book from Respondent No.4. This shall be done as expeditiously as possible and in any case within sixty days from the date of receipt of a copy of the representation.

3. The O.A stand disposed of. No order as to costs.
