Heard Learned counsel for the applicant and Mr. M.C. Jacob, learned Standing Counsel for the Respondents for BSNL and Mrs. K. Rajitha, Sr. Central Government Standing Counsel for the Respondents.

The OA is filed seeking a direction to the respondents to furnish the first and second pages of the Service Register and Service Certificate to attend counselling for the Ph.D in Electronics and Communication Engineering. The applicant who is BSNL employee has to obtain permission from the Department to pursue his Ph.D in Electronics and Communication Engineering. However, the OA is filed with the limited prayer to furnish the aforementioned certificate. It is submitted by the learned counsel appearing for the applicant that the counselling is going to be held on 05.01.2019.

Having regard to the submissions made on either side, the respondents are directed to furnish the applicant first and second pages of Service Register and Service Certificate to attend the counselling Ph.D in Electronics and Communication Engineering which is going to be held in Sri Venkateswara University on 05.01.2019.
