**ORAL ORDER**

**{ As per Hon'ble Mr.Justice R.Kantha Rao, Member (Judl.) }**

The issue requires adjudication in all the OAs being common, they are disposed of by the following common order.

2. The version of the applicants in all the OAs is that they were appointed as Inspectors and were granted ACP in the scale of Rs.7500-12000 on the dates mentioned in the respective OAs. As per the Government of India Resolution and CCS (RP) Rules, 2008 they are entitled for Non-Functional Grade Pay of Rs.5400/- upon completion of regular service of 04 years in the Grade Pay of Rs.4800/- (pre-revised 7500-12000 scale). It is submitted that all the applicants have been granted Grade Pay of Rs.4800/- as per the Resolution Clause (iv) with effect from the dates mentioned in the respective OAs.

3. Respondent No.2 however issued proceedings dated 16.09.2009 with the approval of Department of Expenditure and Implementation where under at Clause (iv), it is observed that Non-Functional Grade Pay will not be granted to such of those Group-B officers who have got Grade Pay of Rs.4,800/- on

upgradation under the ACP Scheme as contrary to the Government Resolution and CCS (Revised Pay) Rules, 2008.

Therefore, all these applicants filed the present OA to declare the action of the respondents in not granting Grade Pay of Rs.5,400/- from the date of completion of regular service of 4 years in the Grade Pay of Rs.4,800/- (pre-revised 7500-12000) as contrary to the CCS (Revised Pay Rules), 2008 and also the judgement of Madras High Court in W.P.No.13225 of 2010 dated 06.09.2010 and confirmed by the Hon'ble Supreme Court in Civil Appeal No.8883 of 2011 dated 10.10.2017 and consequently direct the respondents to forthwith pay Grade Pay of Rs.5,400/- to the applicants with effect from the date of completion of regular service of 4 years in the Grade Pay of Rs.4800/- (pre-revised 7500-12000).

5. The same issue was subject matter of challenge before the Madras High Court in W.P.No.13225 of 2010. The Madras High Court allowed the Writ Petition by order dated 06.09.2010 holding that the impugned executive instructions are contrary to the Government of India resolution and the CCS (Revised) Pay Rules, 2008 and directed the applicants therein to be granted Grade Pay of Rs.5,400/- from the date of completion of regular service of 4 years in the Grade Pay of Rs.4800/-. The said case was carried in appeal to the Hon'ble Supreme Court vide SLP ( C) No.15627 of 2011 by the respondents and the Hon'ble Supreme Court dismissed the Civil Appeal confirming the order passed by the Madras High Court. The Review Petition( Civil) No.2512 of 2018 in Civil Appeal

No.8883 of 2011 filed by the respondents was also dismissed by the Hon'ble Supreme Court. The Tribunal also allowed OA.1051/2010 filed by the employees of Central Excise Department questioning the very same proceedings issued by the 2<sup>nd</sup> respondent dated 16.09.2009.

6. The issue has therefore been finally adjudicated and no longer resintegra. As the Review Petition No.2512 of 2018 was dismissed by the Hon'ble Supreme Court, the applicants in all the cases are entitled for the relief prayed for in the respective OAs.

6. Consequently the proceedings issued by the respondents vide F.No.A-26017/98/2006/Ad-IIA, dated 16.09.2009 are set aside. The respondents are directed to grant Grade Pay of Rs.5,400/- to the applicants with effect from the date of completion of regular service of 4 years in the Grade Pay of Rs.4,800/- .

7. The OAs are allowed accordingly. There shall be no order as to costs.
