This Contempt Petition has been filed by the petitioners for non compliance of the order dated 02.08.2017 passed by this Tribunal in O.A. No.200/00878/2015 (Annexure C/1).

2. Respondents have filed their reply. They have submitted that the said order of the Tribunal had been challenged by the respondents by filing M.P. No.1480/2017 before the Hon'ble High Court of Madhya Pradesh at Indore Bench. The same was dismissed vide order dated 05.01.2018.
