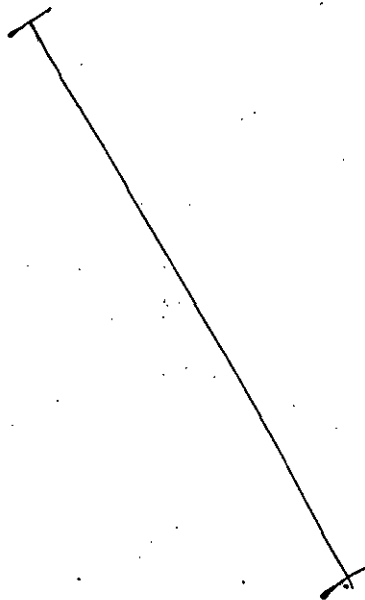

Heard Mr. A.Chakraborty, Ld. Counsel for the applicants, and Mr. S.K.Das, Ld. Counsel appearing for the Official Respondents, in extenso.

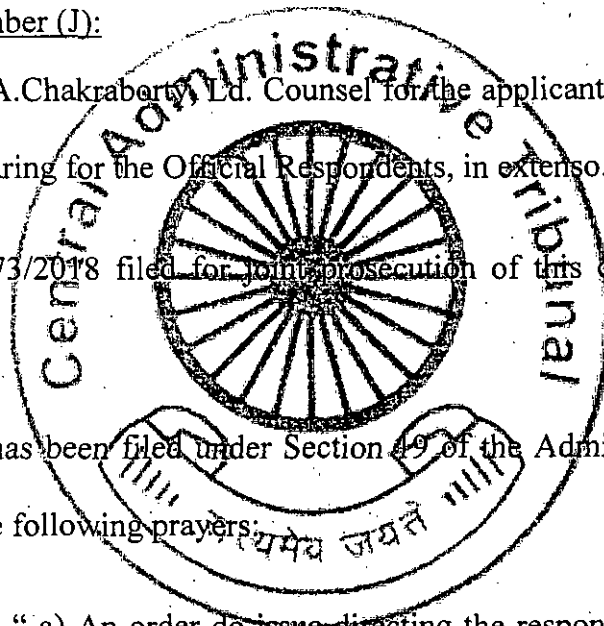
2. M.A.No. 973/2018 filed for joint prosecution of this case is allowed and disposed of.

3. This O.A. has been filed under Section 49 of the Administrative Tribunals Act, 1985 with the following prayers:

" a) An order do issue directing the respondent to grant the benefit of Grade Pay of Rs. 2800/- in favour of the applicant with effect from the date of their promotion to the post Keyman, Mate respectively as per RBE dated 04.03.2014 and corrigendum dated 31.10.2014 and to grant them arrears.

b) Leave may be granted to file this Original Application jointly under Rule 4(5)(a) of the CAT procedure Rule 1987."

4. The case of the applicants as enumerated by Ld. Counsel is that they are working as Keyman/Mate under different Senior Section Engineer (P.Way), Asansol Division, South Eastern Railway. On 04.03.2014 Railway Board issued a circular (Annexure-A/2) to the effect that existing Keyman and Gangmate



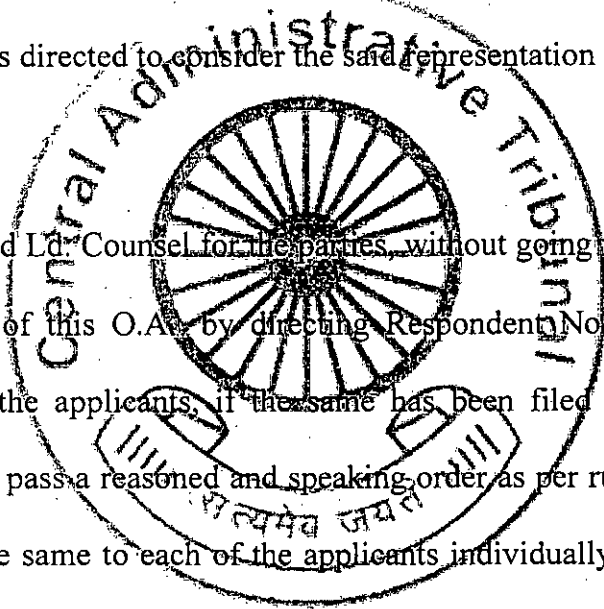

have been re-designated as Track Maintainer Grade-I in Grade Pay of Rs. 2800/-. Corrigendum was issued that the Board has approved duties of re-organised Trackman categories under Engineering Department. Ld. Counsel for the applicants submitted that the categories of Mate and Keyman have been re-designated as Track Maintainer Grade -I in Grade Pay of Rs. 2800/-. He further submitted that ventilating their grievance applicants have preferred common representation on 21.09.2017 and on 11.11.2017 (Annexure-A/4) praying for grant of benefit of Grade Pay Rs. 2800/- since they are working in the post of Track Maintainer Grade-I, which has not yet been considered. He further submitted that grievance of the applicants may be redressed if Respondent No.3 is directed to consider the said representation within a specific time frame.

5. Having heard Ld. Counsel for the parties, without going into the merit of the matter, I dispose of this O.A. by directing Respondent No. 3 to consider the representation of the applicants, if the same has been filed and is pending for consideration, and pass a reasoned and speaking order as per rules and regulations communicating the same to each of the applicants individually within a period of six weeks from the date of receipt of copy of this order. I make it clear that if after such consideration the grievance of the applicants is found to be genuine and they are otherwise eligible then expeditious steps be taken to grant them the Grade Pay of Rs. 2800/-, as claimed by them, within a further period of six weeks from the date of such consideration. I make it clear that if in the meantime the said representation has already been disposed of then the result thereof be communicated to the applicants within two weeks.

6. With the aforesaid observation and direction, this O.A. stands disposed of.
