**O R D E R (Oral)**

The applicants have filed this O.A. seeking the following main relief(s):-

- “(i) *to issue an appropriate order or direction directing the respondents to take the service of the applicants into Old Pension Scheme and not to make deduction from the salary of the applicants under the New Pension Scheme.*
- (ii) *to issue an appropriate order or direction directing the respondents to provide the applicants all consequential service benefits including pension gratuity and GPF etc. in accordance with Old Pension Rules.*
- (iii) *To issue an appropriate order or direction directing the respondents to release the amount which has been deducted by them from the salary of the applicants under New Pension Scheme till date.*

2. The case of the applicants is that they applied for appointment on the post of Diesel/Electric Assistant Driver through Railway Recruitment Board, Chandigarh wherein they appeared in the preliminary examination held on 25.5.2003. Thereafter, the main examination was conducted on 1.2.2004 and the result thereof was declared on 6.5.2004. Thereafter, psychological test was conducted between the period from 10.6.2004 to 23.6.2004 and result thereof was declared on 12.7.2004. All the applicants were appointed on the post of Diesel/Electric Assistant Driver and subsequently they were promoted on the post of Loco Pilot (Goods)/Passenger. The applicants claim that they be treated under Old Pension Scheme instead of New Pension Scheme as their selection is prior to 2004. Being aggrieved, the applicants preferred a representation to the respondent no.2 on 7.5.2018 followed by reminder dated 30.8.2018, but the respondent no.2 did not pay any heed. At this stage, learned counsel for the applicant states that a direction may be issued to the respondent no.2 to consider and decide his pending representation in accordance with law in a time bound manner.

3. Without going into the merits of the case, this O.A. stands disposed of finally at admission stage itself with a direction to the respondent no.2 to consider and decide the representation of the applicant dated 7.5.2018 followed by reminder dated 30.8.2018 within a period of three months from the date of receipt of certified copy of this order in accordance with law by passing a reasoned and speaking order under intimation to the applicant. There shall be no order as to costs.
