**MA No.267/2019** is filed by the  
Applicants for joint petition. For the  
reasons given in the MA, **the MA is allowed.**

2. After arguing the case for sometime,  
the learned counsel for the Applicants seeks  
permission to withdraw the OA with liberty  
to make a representation before the  
competent authority under the respondents  
within two weeks raising all the available  
demands.

3. In the facts and circumstances, the OA  
is disposed of with permission to the  
applicants to withdraw the OA with liberty  
aforesaid. In case, such representation is  
preferred by the applicant within two weeks  
of receipt of certified copy of this order,  
the respondents are directed to consider  
such representation and pass appropriate  
reasoned and speaking order in accordance  
with relevant rules and instructions on the

subject. However, we make it clear that by the present order, we have not expressed any opinion about the merit of the claim of the applicant in any manner. It is further made clear that we have also not expressed any opinion about the limitation, delay or laches, if involved in the matter.
