The applicants in this O.A has contested the recruitment process initiated by Employment Notice, a copy of which is at Annexure A-2 dated 12.12.2018. They are aggrieved by the fact that Bachelor's Degree in Aquaculture which the applicants possess is not included as one of the essential qualifications for the post of Forester in the Department of Environment and Forest in the Employment Notice as well as in the Recruitment Rules which was promulgated on 10.9.2018.

As the process of recruitment is stated to be commencing on 16.2.2019, there is no evidence so as to indicate that the applicants, who possessed Bachelor's Degree in Aquaculture, has taken up the case before the respondents. It would not be appropriate for this Tribunal to interfere in this case at this eleventh hour. Hence the O.A is dismissed. No costs.
