### **ORDER**

#### **NEKKHOMANG NEIHSIAL, MEMBER (A):**

This is a remand case from the Hon'ble Gauhati High Court in WP (C) No. 477/2016 in respect of the applicants who sought for a direction upon the respondents to pay license fee at the rate of 10% compensation per month in lieu of Rent Free Accommodation w.e.f. 01.07.1987 or from their actual date of posting at Dimapur, Nagaland till posted out in reference to the order and judgment passed by this Tribunal, Hon'ble Gauhati High Court as well as Hon'ble Supreme Court.

2. On earlier occasion, this Tribunal vide order dated 02.02.2015 disposed of the O.A. No. 040/00035/2015 and directed the respondents to consider the case of the applicants with due verification with the other similarly situated

individuals/applicants. The respondent authorities aggrieved with the order of this Tribunal dated 02.02.2015, had approached to the Hon'ble Gauhati High Court. The Hon'ble Gauhati High Court vide order dated 28.03.2016 in WP(C) No. 477/2016 has remanded the matter to this Tribunal for its decision afresh after giving an opportunity of hearing to the Union of India i.e. respondents.

3. Today, the case came up for consideration. The learned Addl. CGSC for the respondents Mr. R. Hazarika has informed that this is a settled case. Therefore, he does not want to file formal objection/written statement. Order can be passed and complied with the previous order of this Tribunal.

4. Having heard the learned counsel for the parties, perusal of the pleadings and precedents relied upon, I direct the respondents to decide the present case in accordance with the precedents relied by the learned counsel for the applicants in the case of **Shri Krishna Sinha and 267 Ors. Vs. Union of India and Ors.** after examining the case of the applicants and pay the licence fees at the rate of 10% compensation per month in

lieu of Rent Free Accommodation within a period of two months from the date of receipt of a copy of this order.

5. With the above direction, O.A. stands disposed of accordingly. The shall be no order as to the costs.
