The applicant is working as Veterinary Dresser (erstwhile Group D employee) with the Military Farm, Gwalior.

2. Learned counsel for the applicant submits that in view of the notification dated 28.07.2017 (Annexure A1) issued by respondent No.2 wherein there is an administrative instructions of closure of Military Farm. As per Appendix 'D' of the said instruction, the disposal of held manpower will be in the following manner:-

- (a) No manpower will be retrenched.
- (b) Service Offr are recom for inter Arms Service Tfr (IAST) under aegis of MS Br.
- (c) All permt employees will be adjusted through AG's Br, IHQ of MoD (Army).

3. The applicant has submitted his applications dated 19.08.2017 and 27.03.2018 (Annexure A/2 & A/9) for adjustment out of department through AG's Branch.

4. The respondents in their reply have submitted that the applicant has already been posted at Military Farm Jhansi where he has already joined on 06.07.2018 (Annexure R/2).

5. Learned counsel for the respondents submits that this O.A. has become infructuous as the applicant has already joined at Military Farm Jhansi as per his own choice.

6. Learned counsel for the applicant submits that he may be granted liberty to approach this Tribunal again if any grievance persists after disposal of Annexure A/2 and A/9.

7. In view of the submissions made by the learned counsel for the parties, this Original Application is disposed of having rendered infructuous. However, applicant is at liberty to approach this Tribunal again, if any of his grievances persists.
