2. Learned counsel for the respondents produced order dated 18.02.2019 in C.P. Nos. 648/2017 and 18/2018 filed in O.A. No. 613/2015 which was disposed of by way of common judgment dated 17.11.2016 along with O.A. No. 3540/2015 i.e. the O.A. against which the instant C.P. is filed. This Tribunal, by way of said order closed the said CPs leaving it open to the applicants to pursue further remedies depending upon the outcome of the pending Writ Petition. It was also noted that the Hon'ble High Court observed that the contempt petition, need not to be proceeded with.

3. In the circumstances and in view of the observations made by the Hon'ble High Court in the W.P. filed against the common order, the instant C.P. is closed. Notices are discharged. However, the applicants are at liberty to avail their remedies in accordance with law, once the W.P. is finally decided. No costs.
