ORDER (ORAL)**By Mr. V. Ajay Kumar, Member (J)**

It is seen that the O.A. 2588/2015, against which the instant CP is filed, was disposed of by this Tribunal as under:

“3. In view of the above submission, this O.A. is also disposed of with the direction to the respondents to examine the case of the applicants in the light of the aforesaid judgment of the Hon’ble High Court of Delhi and if they are found covered by it, extend the same benefits to them. This exercise shall be done within a period of two months from the date of receipt of a copy of this order. No costs.”

2. Since the original order basing on which the O.A. of the applicant was disposed of itself not yet complied with in view of SLP pending against the said order, the CP is closed and notices are discharged. However, the petitioners are at liberty to avail their remedies, in accordance with law, after the said SLP is finally disposed of. No costs.
