### **ORDER (ORAL)**

**Hon'ble Sh. V. Ajay Kumar, Member (J)**

Heard Shri Nilansh Gaur, the learned counsel for the applicants and Mr. H. A. Khan, Additional Standing Counsel on receipt of advance notice.

2. M.A No. 1218/2019 filed for joining together is allowed.

3. The applicants, who are working as Pharmacists under the respondents, filed the O.A. seeking the following relief(s):-

“8.1 Direct the respondents to comply with the decision of the Ld. Central Administrative Tribunal was passed vide order dated 12.08.2014 in O.A. No. 2947/2013 (along with batch of OAs) as upheld by the Hon'ble Delhi High Court vide judgment dated 28.03.2017 passed in W.P.(C) No. 717/2015 (along with other writ petitions) and extend the benefit of the same to the applicants, by fixing the pay of the applicants at par with the pay of the new entrant/regular entrant working on the same post from the date of initial appointment, alongwith arrears of pay and interest as per Law with all consequential benefits; and

8.2 Direct the Respondents to extend the benefit of order dated 07.03.2019 to the applicants being identically situated contractual employees and accordingly fix their pay at par with regular/new entrant from the date of their initial appointment alongwith arrears of pay and interest admissible as per law; and

8.3 Direct the respondents to grant the benefit of automatic revision of DA at par with identically situated Contractual Staff as well as the new/regular entrants working as Contractual Staff; and

8.4 Any other relief with this Hon'ble Tribunal may deem fit and appropriate, in the circumstances of the case."

4. It is submitted that the applicants made Annexure A-I (Colly), representations dated 15.03.2019, ventilating their grievances to the respondents. However, no orders have been passed thereon till date.

5. In the circumstances, the O.A. is disposed of at the admission stage itself, without going into the merits of the case, by directing the respondents to consider the said Annexure A-I (Colly), representations dated 15.03.2019 of the applicants and to pass appropriate reasoned and speaking orders thereon, in accordance with law, within 90 days from the date of receipt of a certified copy of this order. No order as to costs.
