## ORDER (ORAL)

**Ms. Nita Chowdhury :**

When the matter is taken up for hearing, proxy counsel for respondent No. 3 states that main counsel is not present.

2. Learned counsel for the applicant takes us through the affidavit and counter affidavit filed by respondent Nos. 1 and 2. He draws our attention to the averments made by the respondent, in which it has been stated that at the time of declaration of the result, the Board has kept the following candidates in the wait list and they have given the details of 17 such candidates and they have further given the details of 11 candidates under the SC category, who are in the select wait list :

The name of the applicant, Mr. Amit Bhardwaj is given under UR - wait list No. 4 and it has been stated that the said candidates did not approach the respondent No. 2 before filing this OA before Tribunal.

3. This is controverted by the applicant's counsel, who points out that even after filing of the OA, the respondent No. 2 has given details about the wait listed candidates and the selection process, but the same is still not declared on the website.

4. We do not find any statement by the respondent No. 2 with regard to the final declaration of the results, in fact, in the counter

affidavit, the respondent Nos. 1 & 2 have further said that these selections are purely provisional, subject to scrutinizing the experience details furnished by the candidates in reference to the essential experience as prescribed in the RRs for the post and the veracity/scrutiny of the experience certificate being technical in nature and as they are not having details about recognition of the social organisation and, hence, they will have to get the same evaluated by the user department.

5. In view of the above averment made by the DSSSB, they are directed to complete verification of qualification and experience certificate within a period of 90 days of issue of this order and thereupon issue the final list of selected candidates in terms of the wait list categories, in case there are vacancies available, within a further period of 45 days thereafter.

6. The OA is allowed with the above directions.
