ORDER (ORAL)

Ms. Nita Chowdhury:

This Original Application pertains to CTET matter and has been filed
by the applicants, seeking the following reliefs:-

- “a) to set aside the Order/Notice dated 04.04.2018 by
which candidature of Applicants rejected by the
Respondent No.2/DSSSB.
- b) direct Respondent No.2 to allow the Applicants to
submit/upload the required documents for the
candidature and further be pleased to allow to
appear in examination for the post of PRT and
TGT categories in term of Order dated 18.01.2018

passed by this Hon'ble Tribunal in OA No. 227/2018;

And/Or

- c) Any other relief, order or direction, as this Hon'ble Tribunal may deem fit and proper may kindly be passed in favour of the applicant and against the respondents, in the interest of justice.”

2. As an interim measures, the applicants were allowed to upload their documents for the post in question and to appear in the examination. Subsequent to that, the result of the CTET exam has been declared and the applicants were directed to state as to whether they have passed the said examination, as adjudication of the OA was only to be taken if they had passed the same. The applicants have failed to file any response in this matter and nobody is present for them either. Hence, in view of the fact that they have not filed any response and not appeared for prosecution of this OA, the same is dismissed in default and for lack of prosecution. No costs.
