## **ORDER (ORAL)**

### **Justice L. Narasimha Reddy:**

The applicants took part in the written examination conducted on 02.02.2014 for selection of Teachers (Primary) with Post Code No.70/09. Their grievance is that several questions were either unrelated to the subject or the key answers were not corrects.

2. These OAs are filed with a prayer to direct the respondents to grant as many grace marks in Section B, as are the questions wrong, irrelevant, ambiguous and out of syllabus, and to declare the result afresh. Ancillary reliefs are also claimed.

3. Both the OAs were adjourned *sine die* on 20.08.2018 by taking note of the fact that the same issue is under consideration of the Hon'ble Delhi High Court in Writ Petition No.6941/2015 and batch.

4. Today, it is represented by the learned counsel for the respondents that the Hon'ble High Court decided the Writ Petition No.6941/2015 and batch on

10.01.2019 and held that the court cannot interfere with the very examination in which the applicants appeared.

5. In view of this development, both the OAs are dismissed. There shall be no order as to costs.
