ORDER (ORAL)

Justice L. Narasimha Reddy, Chairman :-

In this batch of OAs, the applicants claimed the relief in the form of a direction to the respondents to grant the benefit of pay scales, as recommended by Shiv

Shankar Committee and in terms of the Resolution No.1 dated 26.02.1988 passed by the NDMC read with Resolution No. 52 dated 09.06.1988, a settlement between NDMC and its workmen. Reliance is also placed upon a report dated 19.04.1991 passed by a Committee and a Circular dated 26.06.1991.

2. The cases have undergone various stages ever since they were filed. On 17.11.2011, it was observed that the same issue was decided by this Tribunal in TA No.168/2009 - ***Narender Kumar Gaur Vs. NDMC*** and against the order dated 03.08.2010 passed by this Tribunal in that TA, the respondents filed a WP(C) No.1752/2011. The record also discloses that through order dated 17.03.2011, the Hon'ble Delhi High Court had stayed the operation of the order in TA No.168/2009.

3. The present batch of OAs were adjourned *sine die* through order dated 09.12.2011. It appears that Writ Petition is still pending and the parties have not apprised this Court of the developments therein.

4. We are of the view that once the Hon'ble Delhi High Court has stayed the operation of the order in TA

No.168/2009 wherein identical question was involved, the present batch of OAs cannot be decided and there is no point in keeping them pending.

5. We, therefore, close the OAs, directing that it shall be open to the applicants to pursue the remedies, depending upon the outcome of WP(C) No.1752/2011.

There shall be no order as to costs.
