### **O R D E R (ORAL)**

#### **Justice L. Narasimha Reddy:**

This contempt case is filed stating that the respondents did not comply with the directions issued by this Tribunal in its order dated 02.06.2016 in O.A. No.1802/2014. Through the said order, the Tribunal directed the respondents to dispose of the claim of the applicants in terms of circular dated 07.09.2013 till it is modified, i.e., honorarium due to them prior to 25.07.2013 shall be sanctioned according to the rates effective from 01.07.2009.

2. Heard Mr. Yogesh Sharma, learned counsel for applicants and Mr. Ashok Singh, learned counsel for respondents.

3. The contempt case has undergone several adjournments. At one stage, the presence of senior officer of the respondent-organization was also ordered. Today, it is reported by learned counsel for respondents that not only the amounts have been calculated but also released to the applicants.

4. With this, the order passed in O.A. stands complied with. The contempt case is accordingly closed.
