ORDER (ORAL)

Justice L. Narasimha Reddy, Chairman :-

The applicants in these two OAs have retired as Deputy Directors General, in Geological Survey in India, at various stages up to the year 2005. They have filed these two OAs with a prayer to direct the respondents to apply the ratio of the judgment of the Patna High Court in ***M.M.P Sinha Vs. Union of India & Ors.*** CWJC No.10757/2010, and that of the Hon'ble Supreme Court in ***Union of India & Anr. Vs. SPS Vains (Retd.) & Ors.*** SLP (CIVIL) No. 12357 of 2006. Another direction sought by them is to fix their pension at Rs.37,850/-, in terms of the judgments referred to above and to grant notional promotion to S-30 Grade and re-fix the pensions w.e.f. 01.01.2006. Certain other reliefs are also claimed.

2. The respondents filed counter affidavit opposing the OA. It is stated that the pensions of the applicants were determined, in accordance with law, at the relevant point

of time and that the analogy drawn by them is totally untenable.

3. We heard Shri G. Natarajan, learned counsel for applicant and Shri Satish Kumar and Shri Subhash Gosain, learned counsel for respondents.

4. This is one of the rare cases in which the pleadings are extensive and elaborate. What, however, is lacking is the clarity as to the relief, which the applicants claim.

5. The applicants did not have any complaint, as regards the fixation of their pension, when they retired. In case there was any change of law subsequent to their pension, they were certainly entitled to claim the benefits. No such provision is cited, nor any precise relief is claimed. The applicants have undertaken elaborate discussion about certain judgments rendered by the Hon'ble Supreme Court and Patna High Court. It is not in dispute that the parties thereto are not the employees of Geological Survey of India. Day in and day out, hundreds and thousands of cases are filed by employees

of various departments, claiming reliefs under the relevant provisions of law. The relief granted in one case cannot be claimed by the persons belonging to other departments straightway. At the most, analogy can be drawn, if similar provisions are applicable to their service also. As the things stand now, everything is in the state of uncertainty. The applicants did not even make a representation ventilating their grievances. Obviously for that reason, there was no occasion for the respondents to put forward their point of view, succinctly.

6. Under these circumstances, we find it difficult to undertake adjudication. Even now, the applicants can precisely state the relief which they intend to claim by referring to the relevant provisions of law, which are applicable to the Geological Survey of India.

7. We, therefore, dispose of the OAs, leaving it open to the applicants to make a representation ventilating their grievances, if any, as regards the pensionery benefits being extended to them. If a representation is made in this behalf, the same shall be considered by the

respondents and orders be passed within a period of three months thereafter.

MAs, if any, stand disposed of.

There shall be no order as to costs.
