Heard. The matter relates to an allegedly required re-assessment of competitive merit. There were 13 posts of Boat Crew available and by the order of merit the applicant was placed at No. 66. He challenges it but without giving any valid or viable reason as to why he thinks that the examination system was flawed and vitiated. Without any ground being given, there cannot be any re-examination as such as it has been settled by the Hon'ble Apex Court in many number of cases. Therefore, we hold that there is no merit in the OA.

2. The OA is dismissed. No order as to costs.
