The applicant in this Original Application has sought for the following reliefs:-

*“8.1 That the learned Tribunal may kindly be pleased to call the entire records pertaining to the case of the applicants.*

*8.2 That the Hon’ble Tribunal may kindly be pleased to quash the impugned RBE No.28/2018 dated 22.02.2018 (Annexure A/1).*

*8.3 That, the Hon’ble Tribunal may kindly be pleased to quash the impugned provisional seniority list issued as on 01.04.2018 pursuance to merger of grades in light of RBE 28/2018.*

*8.4 Cost of the petition be awarded to the applicants.*

*8.5 Any other relief which the learned Tribunal deems fit and proper may be awarded.”*

2. The respondents have filed their reply, the relevant portion is as under:-

*“4. The order which is impugned namely RBE 28/2018 now does not affect the applicants in view of RBE No.59/2019 dt. 05.04.2019 filed herewith as Annexure R-2 accordingly to which the existing cadres as on 22.02.2018 of Commercial Clerk and ECRC categories would continue to be in separate seniority groups as per the pre 22.02.2018 position. As regards existing employees, instead of keeping only the TC category separate and merging seniority of CC and ECRCs, it is now recommended that all three seniority groups of TC, CC and ECRC would be maintained separately for existing employees. Merger into a common seniority and common functionalities will take place for future direct recruitment with which the present applicants have no concern.*

*5. That consequent upon RBE 59/2019, the impugned provisional seniority list issued as on 01.04.2018 will also be cancelled in due course.”*

3. Learned counsel for the respondents submits that the reliefs prayed for by the applicant have already been granted as submitted in the reply. Therefore, this Original Application may be disposed of as having become infructuous.

4. Accordingly, this Original Application is disposed of as having become infructuous.
