- 1. MA No. 060/01299/2019 is allowed and the applicants are permitted to join together to file this O.A.
- 2. The prayer of the applicants in this O.A. is for stepping up of their pay, at par with their juniors.
- 3. Learned counsel for the applicants admitted this fact that the case of the applicants for stepping up of their pay at par with their juniors is pending consideration. He has drawn our attention to a letter dated 26.04.2019 (Annexure A-1), addressed to one of the applicants namely Partap Singh, whereby it is intimated by the respondents that the case of stepping up of pay shall be processed after receiving the clarification from the Govt. of Punjab.
- 4. Learned counsel, at this stage, prays that since the matter is pending consideration for long time, let a direction be issued to the respondents to finalize the issue in accordance with law in a time bound manner.
- 5. Considering the short prayer of the learned counsel for the applicants, we deem it appropriate to dispose of the O.A, in limine,

with a direction to the Competent Authority amongst the respondents, to consider and take a final view in the matter, in accordance with law, expeditiously, and in any case, but not later than three months, from the date of receipt of a copy of this order.

6. Needless to mention that the disposal of the O.A. shall not be construed as an expression of any opinion on the merit of the case. No costs.
