SANJEEV KAUSHIK, MEMBER (J):-

1. With the consent of parties, matter is taken up for final disposal.
2. Yesterday on 11.9.2019 following order was passed:-

“1. Learned counsel for the applicants informs this Court that the claim of the applicants for stepping up of their pay has been declined on the ground that there is no notification issued by Govt. of Punjab. He submitted that pending O.A. State of Punjab has issued notification dated 22.8.2019, which has been adopted by Chandigarh Administration vide letter dated 30.8.2019 (Annexure A-18). He submitted that once objection raised by the respondents has vanished, therefore, a direction may be issued to them to reconsider the cases of the applicants in terms of notification issued by Punjab Govt. as adopted by Chandigarh Administration. He also submitted that in similar case in O.A. No.60/667/2019, this Court disposed of O.A. in limine by directing the respondents to consider case of the applicant therein for stepping up of pay by passing a reasoned and speaking order. He submitted that case of the applicants herein is on better footing and similar direction may be issued in this case, also.

2. Sh. Aseem Rai, learned counsel for Chandigarh Administration submitted that he has no instructions in this regard and seeks time to have instructions on the plea raised by learned counsel for the applicant, from concerned quarters.

3. List on 12.9.2019.”

3. Today, Sh. Aseem Rai, appearing on behalf of the Chandigarh Administration fairly submitted that he has received instructions from the concerned quarter that this petition can be disposed of in terms of instructions dated 22.8.2019 issued by State of Punjab, as adopted by Chandigarh Administration vide letter dated 30.8.2019. He submitted that since objection of Chandigarh Administration not to step up pay of the applicants was kept in abeyance for want of Govt. of Punjab instructions. The Punjab Govt. has issued notifications as further adopted by Chandigarh Administration as such, let they be given an opportunity to reconsider the case of the applicants in view of these instructions. Learned counsel for the applicants submitted that they

be given opportunity to file supplementary representation within a week from today annexing judgments relied upon by them and those be also considered while deciding their cases.

4. In view of the consensus arrived at between the parties, present O.A. is disposed of in the terms as noticed above, by granting the respondents three months time after receipt of representations to complete the process. M.A. also stands disposed of accordingly. No costs.
