ORAL ORDER

[Pronounced by Hon'ble Mr.P.Madhavan, Member(J)]

The applicant has filed this OA seeking to quash the order of the 3rd respondent in Proceeding dated 06/12.5.2015 and consequently direct the respondents to continue to fix the pay of the applicant based on the Fitment table for the pre-revised pay scale of Rs.7450-11500.

2. The respondents have entered appearance and filed the reply statement. However, today, when the matter is taken up for hearing, learned counsel for the respondent 2 and 3 submits that the relief sought by the applicant had already been granted and he produces a reply to this effect wherein para-6 reads as follows:-

"6. Now ICMR has implemented Merit Based Assessment Promotion Scheme (MBAPS) with retrospective effect notionally from 01.01.1992 and with actual benefit from 01.01.1996. As per this Scheme, Dr.N.Uthayakumaran has been granted the promotions from the date of his initial appointment as follows:-

01/04/99	Sr.Technical Officer(1)	Rs.8000-275-13500

01/04/09	Sr.Technical Officer(3)	Rs.15600-39100+GP-7600
01/04/14	Principal Technical Officer	Rs.37400-67000+GP-8700

With the implementation of MBAPS, Dr.Uthayakumaran has been given assessment promotions retrospectively with the result, the applicant has been

given the pay scale of Rs.10000-325-15200 w.e.f. 01.04.2004, which is much higher than the pay scale of Rs.7450-11500 which was wrongly given to him w.e.f. 01.01.2006. He has also been paid the arrears for the above promotions."

The same is taken on record. Learned counsel for the applicant corroborates the same.

3. Taking into consideration the reply filed by R2&3 and the above submission made by both sides, as the relief prayed for by the applicant has already been granted, nothing survives in this OA and it is liable to be dismissed. Accordingly, the OA is dismissed as infructuous. No order as to costs.
