ORAL ORDER

(Pronounced by Hon'ble Mr. R. Ramanujam, Member(A))

Heard. The applicant has filed this CP alleging wilful disobedience of the order of this Tribunal in OA 1973/2017 dt. 04.01.2018.

2. On perusal, it is seen that the respondents had filed MA 294/2018 seeking extension of time to comply with the order. When the matter was called on 18.06.2018, counsel for the MA applicant submitted that the order of this Tribunal had been complied with and, accordingly, the MA was infructuous. Learned counsel for the applicant in the OA had confirmed the same and had no objection to closing the MA. Accordingly, the MA was disposed of as infructuous.

3. If the order of this Tribunal had been complied with and the counsel for the OA applicant at that time had confirmed the receipt of the same, the same applicant could not be allowed to move for contempt through another counsel.

4. CP is dismissed.
