It is submitted by the learned counsel for the applicant that the applicant has been posted out to Gwalior on promotion as Deputy Commissioner. She submits that the applicant has filed a representation stating that he may be retained at Ernakulam on the basis that he belongs to LTR category.

We are of the view that the OA can be disposed of by directing the second respondent to consider the representation being submitted by the applicant for retention at Ernakulam on the strength of belonging to LTR category. This may be done within the shortest possible time, and in any case within one month of receipt of the representation. Meanwhile, the post in question at Ernakulam may not be filled up.
