**ORDER (O R A L)**

Heard learned counsel for the applicant. Shri.T.C.Krishna takes notice on behalf of the respondents.

2. The applicants are employees under the 2<sup>nd</sup> respondent who are initially appointed as Extra Departmental Agents (EDAs). They claims that though they are doing work as done by the regular employees, they are being discriminated in the matter of payment of wages. They press their claim on the ground that the One Man Commission, which went into the issue of redressal of grievances of the EDAs, had made certain recommendations. The applicants alleged that they are still being denied their just demands.

3. In the light of the facts and circumstances of this O.A., we dispose of this O.A at the admission stage itself by directing the applicants to file a detailed representation before the 2<sup>nd</sup> respondent stating all the facts which are

in their favour within a period of two weeks. The 2<sup>nd</sup> respondent on receipt of the representation so filed shall consider the issue raised therein in accordance with law and dispose of the same within a period of 60 days from the date of receipt of the aforesaid representation. There shall be no order as to costs.
