Applicant has been working as PGT (Mathematics in Jawahar Navodaya Vidyalaya (JNV). He submits that he had filed a representation in December, 2018, a copy of which is available at Annexure A6(a), seeking retention in JNV, Wayanad, in view of his pressing personal reasons. He submitted a further representation also, a copy of which is available at Annexure A2. He submits that on account of the fact that the post at Wayanad has been declared as a notified deemed vacancy, others are likely to apply for the same and he would be displaced, which would be to his great detriment in view of his personal difficulty.

2. At this juncture, we feel that the OA can be disposed of by directing the second respondent to duly consider the representations at Annexure A2 & A6(a) before any decision is taken to transfer the applicant from his present station. Ordered accordingly. OA stands disposed of.
