The applicant is presently working as Pointsman-A at Tikkotti Railway

Station in Palghat Division of Southern Railway. Applicant had submitted an application through proper channel in response to Annexure A-1 notification. The last date of receipt of application was 30.4.2019. From Annexure A-3, we see that the applicant's application was forwarded by her Controlling Officer on 27.4.2019. However, it is seen from the impugned order that her name has been omitted from the list of candidates who are to be allowed to participate in the examination.

2. Mr.Sunil Jacob Jose takes notice on behalf of the respondents.

3. We see that there is substance in the grievance pointed out by the applicant. She has obviously applied for participating in the examination well in time as is seen from the fact that her Controlling Officer had forwarded her application on 27.4.2019 itself. It is also stated that the forwarded application was received and acknowledged in the office of the 3rd respondent.

4. Under the circumstances, the relief prayed for in the Original Application is allowed. Respondent no.3 is directed to accept the application submitted by the applicant in response to Annexure A-1 notification and allow her to participate in the selection process initiated as per Annexure A-1. The Original Application is allowed as above. No order as to costs.
