Heard Sri K.P.Harish, learned counsel for the applicant. Sri Sinu G.Nath, learned ACGSC accepts notice on behalf of the respondents.

2. Applicant is aggrieved by the fact that the post for which he has sought a transfer to GDS ABPM in Nilambur RS S.O., has been earmarked for open recruitment as per Annexure A4. He submits that due to the health condition of his parents, he is unable to discharge the duty of his present post as it involves covering considerable distance by foot.

This Tribunal is of the view that the OA can be disposed of at this stage by directing respondent No.3 to consider the applicant's application for transfer, copy of which is available at Annexure A2 with the forwarding letter at Annexure A3, and dispose it of. Both sides agree with the conclusion arrived at. Ordered accordingly. The above exercise shall be completed as early as possible, at any rate within one month of receipt of this order. OA stands disposed of.
