The OA having been heard on 16th September, 2019, this Tribunal delivered the following order on the same day:

ORDER (oral)

Today, when the matter was taken up, learned counsel for respondents 1 to 3 Sri Thomas Mathew Nellimoottil, Sr.PCGC, produced a copy of the communication issued on behalf of Divisional Personnel Officer, Southern Railway, admitting that an inadvertent error had occurred in calculating qualifying service while revising pension under 7th CPC and the process of issuing revised PPO is currently under process. The process is expected to take 10 further days, according to the communication dated 12.9.2019.

2. Learned counsel for respondents 4 & 5 is present. Learned counsel for the applicant is represented by Sri Siby J.Monippally.

3. This Tribunal is of the view that OA can be closed at this point by directing respondents 1 to 3 to issue the revised PPO before 30th of this month. OA is closed accordingly. The applicant is free to approach this Tribunal again in case of failure to comply with the direction.
