COMMON ORDER

2. Since the facts and the question of law involved in all these OAs are similar, they are being disposed of by this common order.

3. The OAs are filed challenging the tender notifications floated by the respondents for providing unskilled manpower.

4. Applicants are working for the respective respondents organisation as Casual Labour. However, no order of appointment has been issued to them though they are discharging the same nature of duties as are being discharged by the regular employees. When applicants represented for temporary status, respondents issued the tender notifications for supply of unskilled manpower. Obviously, the move was to replace them. Aggrieved, the OAs have been filed.

5. Today, this Tribunal passed a detailed order in OA 350/2018, wherein also similar facts and question of law are involved. Operative portion of the said order, which mutatis mutandis would apply to the present OAs, reads as under:

“IV) Therefore, keeping in view the Hon’ble Supreme Court observations cited above, respondents are directed to consider giving preference to the applicants to be engaged as Casual Labour as long as the work exists on a daily wage basis, till they are replaced by regular employees after due process, as per the policy of the respondents organisation. It is made clear that under the garb of this order, applicants cannot claim temporary status or regularisation, unless they are otherwise eligible for the same as per the policy formulations of the respondents organisation in the years to come.

With the above directions, the OA is allowed. “

6. In the light of the above directions passed in OA 350/2018, these OAs are accordingly allowed. There shall be no order as to costs.
