## ORDER (ORAL)

## JUSTICE G.RAJASURIA, JM,

Heard both. This O.A has been filed seeking the following reliefs:

- i) An order granting leave to the applicants under Rule 4(5) (a) of CAT (Procedure) Rules, 1987 to move the application jointly.
- ii) To direct the respondents to prepare and publish panel including the applicants and offer appointment to the applicants and others strictly in accordance with their order of merit, provided in the vacancy notice of 2012 within period of one month from the date of the order and further directing the respondents to grant all consequential benefits to the applicants.
- iii) An order holding that the with holding of results of the applicants and denial of appointments to them are bad in law and arbitrary as well as in violation of rights guaranteed under Article 14 of the Constitution of India.
- (iv) An order directing the respondents to produce entire records of the case since lying within the jurisdiction of this Hon'ble Tribunal.
- 2. Learned counsel for the applicant would point out that the applicants are the aspirants for the Group D post in response to the Employment Notification dated 29.09.2012. They passed the written test, trade test and also underwent documents verification and medical examination. Yet they are not given job, even though the persons similarly placed have been given job.
- 3. Per contra, the learned counsel for the respondents would submit that there was large scale fraud practice by the various candidates and therefore, the Railway administration is thoroughly scrutinising the records and in respect of those persons where there is no suspection appointment is being given. In that process Railway administration took some time to complete the process. As such he would file a detailed reply thereon.
- personnel the Railway administration developed suspects about others and they are scrutinising in detail of the case and part by part released the list. Hence in such a case we are of the view that O.A may be disposed of by giving following direction:

Railway administration shall give a detailed reply individually to those applicants in this regard after scrutinising their cases within a period of 3 months from the date of receipt of a copy of this order. Learned counsel for the respondent authorities would also submit that if applicants are free from blemish order should be issued accordingly.

O.A is disposed of.
