ORDER (ORAL)

Heard learned counsel for the applicants.

2. MA No.613/2019 filed by the applicants for Joint Petition is allowed.

3. In this OA, the applicants are seeking direction to the respondents for appointment to group D posts with the Central Railway as they had qualified in the recruitment test conducted in pursuance to Advertisement Notification 01/2007 and their names were included in the panel of extra selected candidates. During the hearing today, learned counsel for the applicants submits that the applicants have made representation to the respondents seeking redress of their grievance but they have not yet decided it. In the case record, at page Nos.368 to 372, we find that a representation seems to have been submitted on 21.08.2019 by only six of the applicants. Rest 10 applicants have not yet submitted any representation.

4. After arguing for sometime, the counsel for the applicants submits that the remaining ten applicants would also file a similar representation

with the respondents within one week from today and they would be satisfied if the present OA is disposed of with a direction to the respondents to decide these representations.

5. In view of this submission, the present OA is disposed of with direction to the respondents to decide the pending representation of six applicants dated 21.08.2019, alongwith additional representation if received from the remaining 10 applicants to the present OA before 11.10.2019, by passing a reasoned and speaking common order within one month thereafter and communicate that order to the applicants within one week thereafter.

6. The Original Application is thus disposed of in above terms at the admission stage itself. MA No.614/2019 stands closed. No costs.
