2. Shri A.M.Sethna, learned counsel for
the respondents in both the OAs. Shri Narayan
Prabhu and Shri Hemant Kumar (supervisor)
from Naval Dockyard appears on behalf of the
respondents.

3. The applicants 128 in number in OA
No.339/2014 and applicants 7 in number in OA

No.615/2018 have filed these OAs jointly under Section 19 of the Administrative Tribunals Act, 1985 seeking the following reliefs :-

"8(a). That this Hon'ble Tribunal will be graciously pleased to call for the records and proceedings leading to the issue of order dated 14th June 2010 (Annexure A-1) and after going through the legality or otherwise thereof this Hon'ble Tribunal will be graciously pleased to quash and set aside the same.

8(b). That this Hon'ble Tribunal will be further pleased to direct the Respondents to restore to the Applicants the grade of HSK which they were holding since the time of their initial appointment during the years 1997-2000 or in the alternative to place the Applicants in the grade of HSK-I with effect from 01.01.2006 and further grant all consequential benefits.

8(c). That the costs of this Application be awarded in favour of the Applicants; And

8.d). That such order and further reliefs as are expedient be granted in favour of the Applicants."

4. The learned counsel for the applicants submits that aggrieved of the impugned order dated 14.06.2010 (Annex A-1), the applicants have made various representations through proper channel. However, the same have not been considered and disposed of by the Competent Authority in spite of the fact that the respondents Nos.2 and 3 have requested for furnishing the present status of the decision taken on such representations of the applicants as would be evident from their communication dated

19.04.2013 (Annex A-4).

5. The learned counsel for the applicants submit that the applicants would be satisfied if the OAs are disposed of with a direction to the respondents to consider the pending representations and pass a reasoned and speaking order in time-bound manner.

6. The learned counsel for the respondents under instructions submits that the respondents are not having objection to dispose of the matter as above.

7. In view of the aforesaid, without going into the merits of the claim of the applicants, we dispose of these OAs with a direction to the respondents to consider the applicants' representations within eight weeks from the date of receipt of certified copy of this order. No costs.

8. MA No.527/2018 in OA No.615/2018 for joint petition is allowed.

9. MA No.672/2016 in OA No.339/2014 and MA No.528/2018 in OA No.615/208 for condonation of delay also stands disposed of.
