The proxy counsel for the applicant in
OA No.675/2013 appears and states that they

have not been able to contact the legal heirs to be able to file the requisite affidavit for bringing the legal heirs on record. The applicant in these cases had demised on 12.11.2018 and in the other three cases i.e. OA Nos. 2205/2011, 82/2014 & 674/2013, the applicant appeared in person and the same position prevails in these cases also. It is now nine months since the person demised and this is beyond the stipulated period of 90 days.

2. In these circumstances, all the cases abate. Accordingly, all the OAs stand abated. No costs.
