ORDER (ORAL)

Jayesh V. Bhairavia, Member (Judl.) :- Heard the parties. In the instant O.A., it is contended by the applicants that the applicants are permanent employee of the respondents working as Assistant Telecom Technician (ATT) under the administrative control of Telecom District Manager, Bharat Sanchar Nigam Limited, Dumka in short TDM, BSNL. The main grievance of the applicants is that the applicants have accepted deduction under GPF Scheme therefore the respondents started deduction approximately Rs.2000/- per month under the head of GPF Scheme however in the pay slip GPF balance has been shown as 0.00 in spite of regular

deduction of GPF subscription. The applicants, therefore, the submitted various representation for showing the total balance in GPF of each employee but elicited no response. The last representation submitted by the applicants is dated 28th February 2019 (Annexure A/2 series refer) wherein they have requested the DGM, BSNL, Dhanbad for rectifying the said mistake and showing the total balance in GPF so that they can utilize the said amount for betterment of the life of their family. However, the said representation has neither been considered nor respondents have given the details of balance in GPF account.

2. On the other hand, l/c Shri B.K. Pathak, appearing on behalf of BSNL assured that the pending representation of the applicants will be considered and the applicants will be intimated about their total balance in GPF and it will also be shown in the pay slip.

3. In view of the aforesaid submissions made by the respondents, we dispose of this O.A with direction to respondent no. 5 to consider the representation of the applicant and intimate the applicants within 30 days from the date of receipt of copy of this order.

4. In view of the above, this O.A stands disposed of. No costs.
