ORDER (ORAL)

Shri Justice V.S. Aggarwal

By virtue of the present application, applicants, who are Senior Auditors in the Comptroller of Auditor General of India, seek a direction that they are entitled to the revised scale of Rs. 1640-2900/- retrospectively from 1.1.1986. In support of the claim, the applicants have relied upon the decision of the Guwahati Bench of this Tribunal in OA No. 45/92 decided on 2.11.1994 entitled Ranjit Choudhury & Others vs. Union of India & Others and also OA No. 63/97 decided on 14.09.1999 entitled Shri Hironmoy Sen & Ors. vs. Union of India & Ors. besides some other similarly situated persons. The applicants have also placed on the record a copy of the judgement of the Guwahati High Court in Civil Writ Petition 7598/2001 entitled Union of India & Ors. vs. Shri Hiranmoy Sen & Others whereby the decision of the Guwahati Bench of this Tribunal had been upheld.

2. Learned counsel for the respondents had drawn our attention to the order passed by the Hon'ble Supreme Court in Special Leave to Appeal (Civil) No. 5803/2003 whereby the following order is purported to have been passed and the operation of decisions mentioned above have been stayed.

ORDER

Heard learned counsel for the parties.


Delay condoned in CC 5803 of 2003.


Leave granted in both the cases.

Printing dispensed with. Original record need not be summoned. Let the appeal be heard on present SLP papers. Six weeks' time is granted to file additional documents, if any.

In the meantime, the operation of the judgement under challenge shall remain stayed, provided the appellants shall continue to give the pay scales as per the letter dated 28th February, 2003."

3. Keeping in view the said fact, we dispose of the present application with the direction that parties shall be bound by the final order that may be ultimately passed by the Hon'ble Supreme Court. No further directions are required to be issued in the matter.
