O R D E R (ORAL)

By Justice V.S. Aggarwal, Chairman

By virtue of the present petition, the applicants seek quashing of the notification of 21.1.2002 and the office order of 2.6.2000. They further seek quashing of the promotion order of 8.8.2002. Thirdly, it is prayed that respondents should be directed to consider the candidature of the applicants for promotion to Grade-I of DASS and extend similar benefits as have been extended to the 19 private respondents mentioned in the impugned order.

2. Learned counsel for official respondents states that relief no.3 is in the alternative and cannot be granted.

3. There is no dispute at either end that earlier O.A.No.2937/2001 had been filed which was allowed by this

Tribunal on 19.9.2003. The impugned notification and the office order have already been quashed. Resultantly, the promotion order of the private respondents who have not cared to contest should be also be quashed.

4. For these reasons, on parity of reasoning given in O.A.2937/2001, the present petition is allowed. The alternative relief prayed, need not be granted.
