

as are grounded on one same set of facts and law.

2. Applicants in OA 1963/2003 are employed as Technical Clerk (LD) & (UD) (applicants 1 to 29) and Applicant 30 to 33 as Technical Assistant and are re-designated as Data Entry Operators Grade A, B & C, Data Processing Assistant and Jr. Programmer/Programmer in the Ministry of Defence.

3. Consequent upon recommendations of the 4th Central Pay Commission (CPC), Dr. Sheshagiri Committee examined the matters and recommended to the Govt of India the revised pay structure. The Ministry of Finance vide their orders dated 8.1.89 and 20.1.95 revised the pay scales w.e.f. 11.9.1989 which were later revised by other Ministries (Respondents 1 and 3) also from 1.1.86 as per orders in OA 351/99 filed by Rajender Kumar Pareek & Others Vs Union of India & Another and OA 2639/1999 in the case of Babu Lal & Others Vs Union of India and ors. by an order dated 31.7.2000 answered the reference by granting benefit of OM dated 11.9.89 to the similarly circumstance employees with effect from 1.1.86 with all consequential benefits.

4. Applicants impugns letter dated 18.6.2003 where request for grant of benefits w.e.f. 1.1.86 was turned down.

5. Similarly in OA No.2484/ 2003 (filed by I S Vats & Others Vs UOI & Ors) order passed on 30.7.2003 where extension of benefit had been restricted to the applicants in OA 351/1999 and denying the benefit to the applicants has been assailed.

6. In OA 2486/2003 (filed by R K Gupta & 31 Ors. Vs UOI & Ors.) letter dated 30.7.2003 denying the benefits to them has been assailed.


7. On perusal of the rival contention of the parties we are satisfied that the applicants are identically situated and similarly circumstance with those applicants in OA 351/1999. The aforesaid decision as well as decision of the full bench (supra) which is binding on us in all these four covers the case. As such they are entitled for revised scale w.e. f. 1.1.86 with all consequential benefits.

8. Learned counsel for respondents' vehemently contested the OAs and stated that Department of Expenditure has rejected the plea of the applicants.

9. A constitutional bench decision of the apex court in K\_C\_Sharma\_&\_Ors\_Vs.\_.\_UOI\_&\_Ors\_(1987(3)\_AIC 1744) has ruled that similar benefits cannot be denied to the identical situated persons. We are also of the view that if the judgement is in rem the same should be implemented in respect of those who are equally situated. This curtails multiple litigation and brings uniformity in Government action negating violation of Article 14 and 16 of Constitution of India.

9. In the result the above three OAs are allowed. Impugned orders are quashed. Respondents are directed to re-fix the EDP pay scale in respect of applicants w.e.f. 1.1.86 with all consequential benefits. The directions should be complied with within a period of three months from the date of receipt of this order. These orders to be kept in each file.
